- The EOSC Federation Handbook is being written collaboratively with open consultations, meetings, events and sprints.

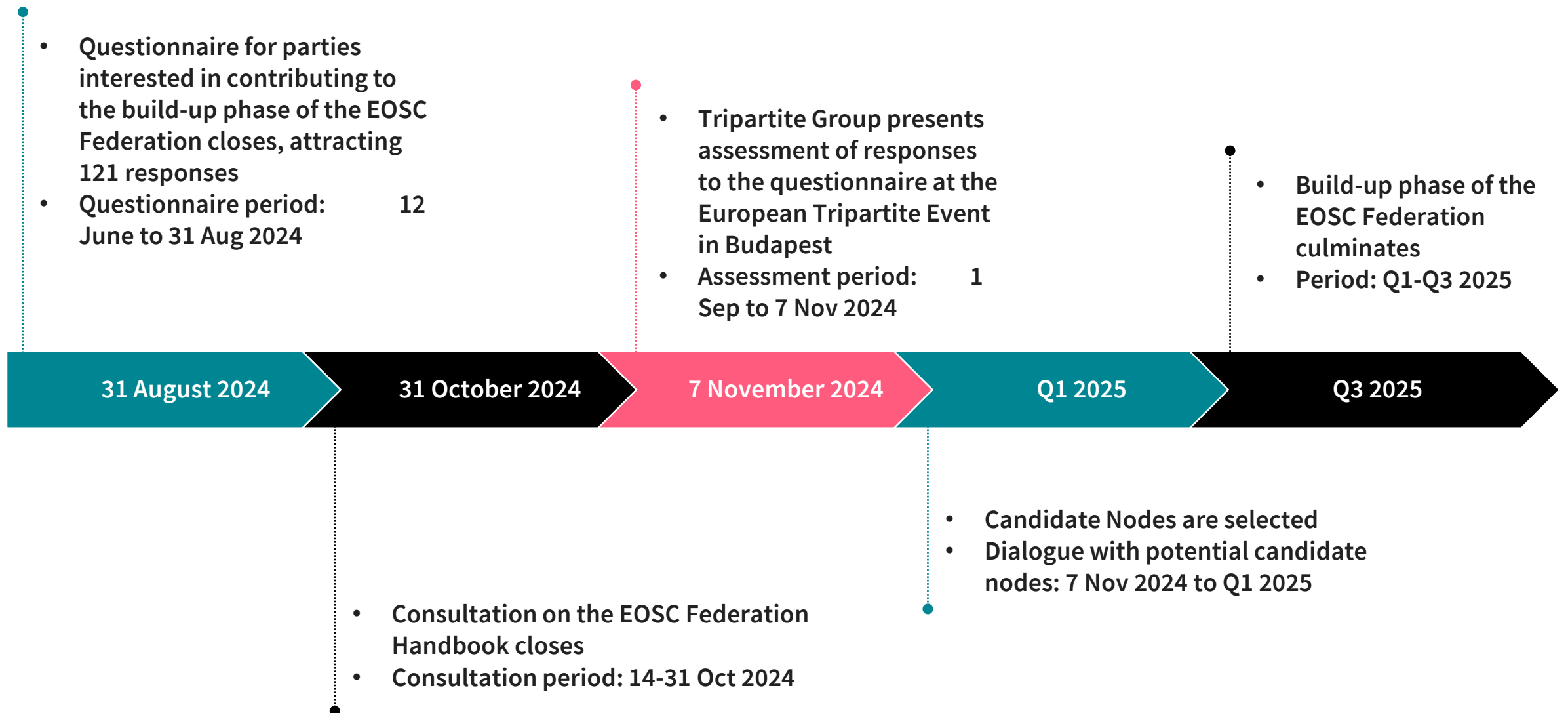

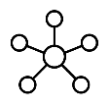




EOSC-A has grown into a dynamic, well-structured and responsive entity, representing the full diversity of our community
